Equipment and systems covered by this certificate are as follows:

The intrinsically safe, rugged tablet computer IS910.2 with efficient Octa-Core processor has been designed for use in explosion hazardous areas of zone 2 and 22. The tablet computer provides numerous technologies like 4G (LTE), NFC, GPS, Wi-Fi and Bluetooth.
